SUBJECT: COVID-19 Guidance Message 8: Temporary Modification to VCCS Policy 6.6.3 and Guidance on

Admission and Placement of New Dual Enrolled Students During COVID-19 Closures

As of November 2, 2020, This Guidance Is Extended through Fall 2021

In March 2020, Chancellor DuBois temporarily approved a modification to VCCS Policy 6.6.3, Dual Enrollment Student Admissions, that added flexibility to use additional measures for dual enrollment admission and placement due to the COVID-19 emergency. This temporary modification for dual enrollment admissions and placement is extended through Fall 2021.

For rising high school juniors and seniors who do not have access to test scores (VPT, Compass, Asset, PSAT, SAT, ACT, SOL), colleges may continue to use the Dual Enrollment COVID-19 Emergency Admission and Placement Procedures, outlined below, for enrolling students in summer and fall 2021 terms:

Please note the following:

- The Dual Enrollment Emergency Admission and Placement Measures are consistent with VCCS Multiple Measures Policy 6.4.0.2.
- These emergency procedures apply to rising high school and home school juniors and seniors enrolling in summer and fall 2020 terms.
- We encourage colleges to create an Advising Form to gather information about Algebra 2 completion and GPA for students who cannot provide transcript information.
- We do not have GPA guidance for admission and placement of freshmen and sophomores, and we ask that colleges continue to determine their college readiness on a case-by-case basis, per Policy 6.6.3.
- Documentation of parental permission remains as a requirement for all dual enrollment students.
- Colleges may not enroll high school or home school students in developmental education courses.
